Aamachhodingmo Rural Municipality, Rasuwa invites electronic bids from Nepalese eligible bidders for the construction of Gre Gaun Bhitrako Sadak Starunnati (Invitation for Bids No.: AAMA/WORKS/NCB/01-2082/083) under National Competitive Bidding procedures. The estimated amount for the works is Rs. (in NRs) 16386653.76 (Exclusive of VAT and Contingencies).

5. Electronic bids must be submitted to the office Aamachhodingmo Rural Municipality, Goljungbesi, Rasuwa, Bagmati Province, Nepa through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 18-09-2025 12:00.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 18-09-2025 14:00 at the office of Aamachhodingmo Rural Municipality, Goljungbesi, Rasuwa Bagmati Province Nepal.
7. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 555000.0, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
