- The bids will be opened in the presence of Bidders' representatives who choose to attend at 21-01-2024 14:00 at the office of Aamachhodingmo Rural Municipality, Goljungbensi, Rasuwa, Bagmati Province, Nepal.
- Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format amounting to minimum of above mention which shall be valid for 30 days beyond the validity period of the bid.
